CHAP. LVIII.

IX. C H A P. LIX.

An ACT to appoint commissioners to examine, survey and lay out, Passed 3d of Jun. 1800. the feveral roads therein mentioned.

THEREAS it appears, from the representation of the commissioners of review for Baltimore Preamble. county, that the commissioners appointed by law to examine, survey and lay out, a road leading from Rifter's-town, in said county, to the Pennsylvania line, in a direction to Hanover-town, and likewise the commissioners appointed by law to examine, survey and lay out, a road leading from the city of Baltimore, in a direction towards Liberty-town, in Frederick county, to the Frederick line, at or near Philemon Barn's plantation, have not made fuch return as will enable the faid commissioners of review to confirm either of the aforesaid roads, and that some of the said commissioners have, fince their appointment, departed this life, and others have moved out of the county, and they request that commissioners may be appointed to examine, forces, lay out and mark the same, therefore,
