V. AND BE IT ENACTED, That upon the faid petitioning debtor's executing and acknowledging 2 On executing a deed to the trustee to be appointed as aforesaid, conveying all his property, real, personal and mixed, deed, to be dif- deed to the trustee to be appointed as aforesaid, conveying all his property, real, personal and mixed, and all debts, rights and claims, agreeably to the oath, or affirmation, of fuch debtor as aforefaid, and on his delivery to the faid trustee of all his faid property which he shall have in possession, and of his books, papers, and evidence of debts of every kind, and the faid truftee's certifying the same, in writing, to the chancellor, it shall be lawful for the chancellor to order that the said debtor shall be discharged from all debts, covenants, contracts, promises and agreements, due from, or owing or contracted by him, before the date of the faid deed, and by virtue of such order the faid debtor shall be discharged as aforesaid; provided, that no perion who has been guilty of a breach of the laws, and hath been fined, or is liable to be fined, for fuch breach, shall be discharged from the payment of any fine incurred for any breach of the laws or this state; and provided, that any property which he shall thereafter acquire by gift, descent, or in his own right by bequest, devise, or in any course of distribution, shall be liable to the payment of the said debt; and provided, that the discharge of such debtor shall not operate so as to discharge any other person from any debt.

VI. AND BE IT ENACTED, That the chancellor may allow fuch petitioning debtor to retain the May retain his necessary wearing apparel of himself and family. apparel.

VII. AND BE IT ENACTED, That the chancellor may direct any trustee to be appointed by virtue directed to fell, of this act to fell and convey the property conveyed to him by the petitioning debtor, at such time, and on fuch terms and conditions, as he shall think most for the advantage of the creditors, and the produce thereof, after fatisiying all incumbrances and liens, shall be divided among the faid creditors, agreeably to the feveral and respective claims, but no judgment to be entered after the passage of this act against any of the said debtors who shall take advantage of this act, shall be a lien on his real property, nor shall any process against his real or personal property have any effect thereon, except writs of fieri facias actually and bona fine faid before the pailing of this act.

May sue, &c.

VIII. AND BE IT ENACTED, That any trustee may sue for, in his own name, and recover, any property or debts affigned to him by any debtor in virtue of this act.

When fraud, &c. is alleged, debtor may be examined, &c.

IX. AND BE IT ENACTED, That if any creditor, on the application of any such debtor to the chancellor, or within two years thereafter, shall allege, in writing, to the chancellor, or to the general court of the shore, or the county court of the county, where such debtor shall reside, that such debtor hath directly or indirectly fold, conveyed, leffened, or otherwise disposed of, or purchased in trust for himself or any of his samily or relations, or any other person or persons, interested or concealed, any part of his property of any kind, or any part of his debts, rights or claims, thereby to deceive or defraud his creditors, or any of them, or to fecure the same, or to receive or expect any profit or advantage thereby, or that he has palled bonds, or other evidences of debts, either without confideration, or on improper confideration, or lost more than one hundred pounds current money by gaming at any one time, or hath affigned or conveyed any of his property, with intent to give an undue and improper preference to any creditor or creditors, or fecurity, within two years before the passage of this act, the said chancellor or court may thereupon, at the election of the creditor making fuch allegation, either examine the faid debtor, and any person or persons to whom he may have made any conveyance or conveyances of his property, or pailed bonds or evidences of debts as aforefaid interrogatories, on outh or affirmation, touching the subject of the said allegations, or direct an issue or issues, in a summary way, without the form of an action, to determine the truth of the same; and if, upon the answer of the said interrogatories, or the trials of the said issue or issues by a jury, fuch debtor shall be found guilty of any fraud or deceit of his creditors, or loss by gaming as aforesaid, or of having given preference as aforesaid, he shall be for ever precluded from any benefit of this act; and in case such debtor, or other person, shall, at any time thereased, upon any indictment, be convicted of wilfully, falfely and corruptly, fwearing or affirming to any matter or thing to which he shall swear or affirm by virtue of this act, he shall suffer as in case of wilful and corrupt perjury, and be for ever debarred from any benefit of this act.

X. AND BE IT WACTED, That the chancellor may allow any trustee to be appointed by virtue of this act fuch commission for his trouble as he shall think reasonable, not exceeding eight per cent. and Commission allowed.
