RESOLVED, That the state release its interest to the composition or valuation of the land escheated by Thomas Berry, of Kent county, and the register of the land-office of the eastern shore is hereby directed to issue patent on the land included in said escheat warrant, with an estate to Thomas Berry for life, remainder to William Reed, his heirs and assigns; saving all rights heretofore acquired by any person to or in said lands, or in any part thereof.

RESOLVED, That Tristram Martin and Abner Parrott, two securities of Daniel Powell Cox, formerly sheriff of Talbot county, be and they are hereby allowed to make payment of the principal sum due to this state, and recovered against them by judgments respectively obtained in the general court of the eastern shore at September term, seventeen hundred and ninety-nine, with six per cent. interest thereon from the time stated in the said judgments, on or before the first day of May next, and that execution thereof be accordingly stayed; and that on the payment of the said principal sum, with interest of six per cent. as aforesaid, and the several costs of suit, on the said first day of May, the said Tristram Martin and Abner Parrott be released from the payment of the sisteen per cent. imposed for the non-payment thereof by the time limitted by law.

RESOLVED, That the personal property and debts heretofore placed in the hands of James Brice, brother and trustee for the use of Elizabeth, widow of Lloyd Dulany, be transferred and delivered over to Walter Dulany, husband of said Elizabeth.

RESOLVED, That this state extend to Gassaway Watkins the time for paying the balance he owes to this state, viz. that no process shall issue against the said Gassaway Watkins, or his securities, provided he or they pay to the state the whole interest, and one half of his debt to the state, on or before the sirst day of November, eighteen hundred, and the other half, with interest, on or before the tenth day of November, eighteen hundred and one, and all costs that have accrued, if any.
