THEREAS Edward Hargadine, of Queen-Anne's county, and George Carnaghan, of the city Preamble. of Baltimore, by their petitions to this general affembly have set forth, by reason of many misfortunes they are unable wholly to fatisfy their creditors, and have prayed for the benefit of an act of infolvency, upon their delivering up all their property for the use of their creditors; therefore,
