C H A P. XVIII.

An ACT to empower the levy court of Prince-George's county to Passed 6th of January, 1803.

assess a sum of money for the purpose therein mentioned.

WHEREAS Robert Wade, of Prince-George's county, by his petition to this general assembly Preamble. has set forth, that he is far advanced in life, being eighty years of age, and for sometime past has been deprived of his sight, having both of his eyes bursted from a severe fever, and prays that a law may pass for his support out of the poor-house; and the prayer of the petitioner appearing reasonable, therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That the levy court of Prince-George's Court to assess county shall be and are hereby directed and empowered, at their levy courts annually, so long as money, &c. they may see cause, to assess and levy on said county a sum of money, not exceeding fifty dollars, for the support and maintenance of the said Robert Wade, and that the same be collected and paid annually to the aforesaid Robert Wade by the collector or collectors of Prince-George's county, agreeable to the order of the levy court aforesaid.

· C H A P. XIX.

An ACT to empower the justices of the levy court of Anne-Arun-Passed 8th of January, 1803. del county to assess and levy annually a sum of money for the

purposes therein mentioned.

THEREAS sundry inhabitants of Anne-Arundel county, by their petition to this general as- Preamble. sembly, hath set forth, that a certain Ruth Young, of the county aforesaid, through old age and infirmities, is rendered incapable of maintaining herself, or son Benjamin, now forty-one years of age, who, by his deformity, is totally unable to contribute in any manner towards his support, and pray that a law may pass for the support of said Ruth Young and son Benjamin out of the poorhouse; and the prayer of the said petitioners appearing reasonable and proper, therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That the justices of the levy court of Justices to as-Anne-Arundel county, at their levy court, shall have full power and authority, and they are hereby sess money, directed and required, annually to assess, so long as they shall see cause, on the assessable property of said county, a sum of money, not exceeding seventy dollars, which said sum, so levied and assessed, shall be collected as other county charges are, and paid to the said Ruth Young, or such other person as they, the said court, shall appoint, for the use, support and maintenance, of said Ruth Young and her son Benjamin.

C H A P.

An ACT to confirm an act, entitled, An act to alter such parts of Passed 8th of January, 1808. the constitution and form of government as relate to voters, and qualifications of voters.

E IT ENACTED, by the General Assembly of Maryland, That an act passed at November session, An 28 con-Beighteen hundred and one, entitled, An act to alter such parts of the constitution and form of firmed. government as relate to voters, and qualifications of voters, shall be and the same is hereby confirmed.

A Supplement to an act, entitled, An act authorising a lottery in Passed 8th of January, 1801. Havre-de-Grace for the purpose therein mentioned.

WHEREAS the monies arising from the lottery authorised to be drawn by the original act to Preamble. which this is a supplement are by no means adequate to the building and erecting public wharfs in the town of Havre-de-Grace, as contemplated by the said original act, and as the appropriation of said monies, in addition to monies already subscribed, or hereafter to be subscribed, towards the building of a church, parsonage-house and market-house, will be of a more immediate benefit to said town; therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That the residue of the monies arising Residue of mofrom said lottery, after payment of prizes and necessary expences, as directed in the said original act, nies, how to be be and the same shall be applied by the commissioners of said town, or a majority thereof, towards applied.
