C H A P. CXLVI.

An ACT to alter the time for holding the county court of Montgo- Passed 20th of January, 1808. mery county.

BE IT ENACTED, by the General Assembly of Maryland, That in future the fall session of the county Court, when to court for the county of Montgomery shall be held on the second Monday in the month of No- be held. vember yearly, and every year.

C H A P.

A Further supplement to the act, entitled, An act to incorporate Passed 20th of January, 1808. companies to make several turnpike roads through Baltimore county,

and for other purposes.

HEREAS it is represented to this general assembly, that the Baltimore and York turnpike Preamble road, as laid out by the commissioners of review in Baltimore county, between the Western run and the Pennsylvania line, have laid out the said road on a straight line, although it passes over extreme high rocky hills and precipices, and by varying or altering the course from one to eight perches in a few places, would lay it out on better ground, not lengthen the course, and save considerable sums of money to the corporation; therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That the president and managers of said President, &c. corporation shall and they are hereby authorised and directed, to make any alteration in the York may make any turnpike road, as confirmed by the commissioners of review, from the Western run aforesaid to the alteration, &c. Pennsylvania line, so as the said turnpike road shall not vary from the bed or course of the road, as laid out by the commissioners of review more than eight perches, and shall again return into the bed or course of the said road as soon as convenient; and when the said road shall be so altered and laid out, two correct plots thereof shall be made out, one to be returned to the clerk of Baltimore county, and one to the register of the city of Baltimore, to be by them recorded amongst their records.

C H A P. CXLVIII.

An ACT to provide for the making passable through Baltimore Passed 20th of January, 1808. county the public road laid out from the city of Baltimore to the town of Belle-Air, in Harford county, and the public road laid out from Gravelly hill, on the Reister's-town turnpike road, to Philemon Barnes's plantation on the Frederick county line.

BE IT ENACTED, by the General Assembly of Maryland, That the justices of the levy court of Balti- Justices to emmore county, after the first day of February next, shall employ not exceeding one third part of ploy only one third of the crithe number of the criminals labouring on the public roads of Baltimore county, in opening, repairing, and making passable for carriages of burthen through Baltimore county, the aforesaid public road now laid out from the city of Baltimore to the town of Belle-Air, in Harford county, and shall employ the remaining part of said criminals in opening, repairing, and making passable for carriages of burthen through Baltimore county, the aforesaid public road leading from Gravelly hill, on the Reister's-town turnpike road, to Philemon Barnes's plantation on the Frederick county line.

II. And BE IT ENACTED, That the said justices of the levy court, or a majority of them, shall And view part and they are hereby directed to view and inspect that part of said road leading from Baltimore-town of the road, kee to Belle-Air which crosses two large hills at the White Marsh run, and that part thereof passing from the south side of the Great Falls of Gunpowder to or near the mouth of Mr. Gough's lane on said road, and to change the location, course and direction, of the said road thereat, in such manner as to them shall seem right and proper for the promotion of the public convenience, which said changes and alterations, when made as aforesaid, shall be deemed and considered, to all intents and purposes, as the original location or course of said road; and the said justices of the levy court shall sause a plot of said alterations and changes to be returned to the office of the clerk of Baltimore county, to be recorded as the plots of other public roads are; and the said justices of the levy court of Baltimore county are hereby authorised and empowered to shut up such parts of the said last mentioned public road as may be rendered useless by the said alterations and changes.
