C H A P. XII.

A Further supplement to the act, entitled, An act relating to the public roads in the several counties therein mentioned.

Passed 20th of Dec. 1808.

BE IT ENACTED, by the General Assembly of Maryland, That all and so much of the thirteenth section of the original act to which this is a further supplement, and the third section of the supplement to the said act, so far as the said sections relate to, and operate upon, the inhabitants of Dorchester county, be and are hereby abrogated and repealed, any law to the contrary notwithstanding.

C H A P. XIII.

An ACT annulling the marriage therein mentioned, being supplementary to an act, entitled, An act for the relief of Mary Gwinn, of Frederick county.

Passed 20th of Dec. 1808.

BE IT ENACTED, by the General Assembly of Maryland, That the marriage mentioned in the preamble of the original act, to which this is a supplementary act, stated to have been heretofore had and solemnized between Thomas Boylan and Mary Good, (now Mary Gwinn,) be, and the same hereby is declared to be, absolutely and to all intents and purposes null and void, and the said Thomas Boylan and the said Mary are hereby declared to be divorced *a vinculo matrimonii*.

Marriage declared void.

II. AND BE IT ENACTED, That the marriage mentioned in the said preamble of the original act, to which this is a supplementary act, stated to have been heretofore had and solemnized between John Gwinn, now deceased, and the said Mary, be and the same hereby is confirmed and made valid and effectual in law, to all intents and purposes whatsoever, in the same manner, as if the marriage herein before mentioned to have been had and solemnized between the said Thomas Boylan and the said Mary had never taken place.

C H A P. XIV.

An ACT for the relief of petit jurors of Baltimore county court.

Passed 22d of Dec. 1808.

BE IT ENACTED, by the General Assembly of Maryland, That to every court hereafter to be held for Baltimore county, there shall be summoned twenty-four petit jurors to serve during the first three weeks of the term, and twenty-four other jurors to serve during the remainder of the term; and it shall be the duty of the sheriff in summoning the said jurors, to notify each, in writing, of the day and hour when he is to attend, and also the time during which he is to serve.

C H A P. XV.

An ACT authorising George Robertson and Dorothy Robertson to convey certain lands therein mentioned.

Passed 20th of Dec. 1808.

WHEREAS it hath been represented to this general assembly, by the petition of John Leatherbury, of Robert, that Robert Robertson, late of Somerset county, deceased, being seized of certain lands lying and being on Monie creek in said county, devised the same to Anne Hack Robertson, wife to the said deceased, for and during her life, with remainder over to the children of his two brothers, George and James Robertson, deceased, in fee; that the said George Robertson and Dorothy Robertson, widow of the said James Robertson, believing it for the advantage and interest of the said children, sold the said lands to Samuel Holbrook, of said county, and the said George and the said Dorothy passed their bond for the conveyance of the same, in the penal sum of five thousand pounds; that afterwards the said Holbrook sold the said lands to the petitioner, in fee, who prays that an act may pass empowering the said George and the said Dorothy to convey the same to him, as the children of the said George and the said James are minors, (except James Robertson, eldest son of the said James Robertson, deceased, who hath already made conveyance,) and are incapable of doing it; and the prayer of the said petitioner appearing reasonable, and the sale of the lands to be advantageous to the children, under the peculiar circumstances before recited, therefore,
