A Further additional supplement to an act, entitled, An act to in- Passed 23d of Dec. 1808. corporate companies to make several turnpike roads through Baltimore county, and for other purposes.

BE IT ENACTED, by the General Assembly of Maryland, That the period of time allowed to the Time extend-stockholders of the Baltimore and Reister's-town turnpike company for agreeing to the extension of the road mentioned in the act passed at November session, eighteen hundred and five, entitled, A further supplement to an aci, entitled, An act to incorporate companies to make several turnpike roads through Baltimore county, and for other purposes, be and the same is hereby extended for the term of three years after the expiration of the period aforesaid, which is prescribed in the said act.

An ACT to revive and continue an act, entitled, An act authorising Passed 23th of Dec. 1828. Joseph Green, late sheriff and collector of Charles county, to complete his collection.

BE IT ENACTED, by the General Assembly of Maryland, That an act passed at November session, An act revived, eighteen hundred and seven, entitled, An act authorising Joseph Green, late sheriff and collector of Charles county to complete his collection, be and the same is hereby revived and continued until the first day of December, one thousand eight hundred and nine.

C H A P. LII.

An ACT to authorise the judges of Saint-Mary's county court to Passed 23td of Dec. 18ck. direct a division or sale of the real estate of Robert Young, late of Saint-Mary's county, deceased.

HEREAS it is represented to this general assembly, by the petition of Jonathan Abel, and Preamble, Harriet Abel his wise, Philippa Y. Corum, Anne Corum, Jemima Corum, Elizabeth Corum, Lucretia Corum, John Corum and Maria Thomas, devisees of Robert Young, late of Saint Mary's county, deceased, that they have a right in common to a tract or parcel of land under the will of the said Young, and that it will conduce much to their interest that it should be divided or sold, for the benefit of the petitioners; and the same appearing reasonable, therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That an application of the said devisees. On application, or either of them, or the guardians of either of the minors, to the judges of Saint-Mary's county judges to court, the said judges shall, and they are hereby authorised and empowered, to appoint commissioners, to divide or sell the real estate of the said Robert Young, on such terms as to them shall seem proper, and the money arising from the sale thereof shall be applied to the use and benefit of the devisces of Robert Young, agreeably to the last will and testament of the said Young; provided, that such sale shall not be decreed unless it shall appear to the said judges that it will be for the advantage of those of the said devisees that are minors.
