

A LIST OF LAWS PASSED NOVEMBER SESSION, 1809.

An act to authorise Elizabeth Philpot, of Frederick county, to dispose of the land therein mentioned.

An act to lay out and straighten a certain road in Harford county.

An act to empower the inhabitants of the town of Havre-de-Grace to elect the commissioners thereof.

A Further supplement to an act authorising a lottery for raising a sum of money for repairing of Saint-George's church, on Deer creek, in Harford county.

An act for the benefit of Elizabeth Barner, of Washington county.

An act to empower the administrator of Joseph Baxter, late sheriff of Cæcil county, to collect the fees put into the hands of the said Baxter for collection in his life-time.

An act authorising William Bruce, late sheriff and collector of Allegany county, to complete his collections.

An act authorising Thomas Greenwell to remove his negroes from the state of Virginia into this state.

An act to admit persons conscientiously scrupulous of taking on oath to serve as jurors.

An act to authorise the drawing of a lottery or lotteries in Middle-town, in Frederick county.

An act to incorporate a company for making an artificial road from French-town, on Elk river, in Cæcil county, in the state of Maryland, to the Delaware line, in a direction towards the town of New-Castle.

An act to repeal and abolish the forty-fifth article of the constitution and form of government.

An act for the relief of John Campbell, of Queen-Anne's county.

An act annulling the marriage of Ephraim Furniss, and Polly his wife, of Somerset county.

An act providing for the payment of the costs which accrued upon the trial of Thomas Burk, in Washington county, at March term, one thousand eight hundred and nine.

An act to lay out a road in Baltimore county.

An act to lay out, straighten and amend, a certain road in Harford county.

An act authorising a lottery for raising a sum of money for the purpose of erecting a building to be called The Baltimore Female Academy.

An act for the benefit of the children of John Green, late of Dorchester county, deceased.

An act authorising a lottery to raise a sum of money to purchase a fire engine, and to erect a house, with an alarm bell thereon, in the western precincts of Baltimore.

An act authorising John M^cWilliams, late sheriff and collector of Saint Mary's county, to complete his collection.

An act to authorise a lottery or lotteries in Frederick county.

A Supplement to the act, entitled, An act for the recovery of small debts out of court, and to repeal the acts of assembly therein mentioned.

An act to lay out and make public a road therein mentioned in Cæcil county.

An act to open a road to Swan creek, in Harford county, and to make a public landing place thereat.

An act authorising George Creager, junior, late sheriff of Frederick county, to complete his collection.

An act to incorporate a company for the purpose of building a bridge over the river Susquehanna at Havre-de-Grace.

An act authorising the levy court of Washington county to levy a sum of money for the purpose therein mentioned.

An act to fix and establish Argyle alley in the city of Baltimore.

An act to alter such parts of the constitution and form of government of this state as relate to voters and qualification of voters.

An act to authorise the drawing of a lottery in Frederick-town for the purpose of paving Market-street in said town.

An act to authorise and empower the justices of the levy court of Dorchester county to assess and levy a sum of money for the purpose therein mentioned.

An act authorising Zachariah Duvall, collector of Anne-Arundel county, to complete his collection.

An act to widen a road in Frederick county.

An act to lay out and make public a road in Baltimore county therein mentioned.

An act for the relief of Henry Alexander, of the city of Baltimore, an insolvent debtor.

An act to open a road in Frederick county.

An act to incorporate a company to make a turnpike road from the town of Westminster, in Frederick county, through Harman's Gap, to Hagar's-town, in Washington county.

An act for the relief of Edward Foard, of Cæcil county.

An act authorising Joseph M^cKeney, late sheriff of Anne-Arundel county, to complete his collection.

An act to lay out and open a road from the Little Tonoloway creek, in Washington county, to the Pennsylvania line.

An act authorising Philemon C. Blake, late sheriff of Queen Anne's county, to complete his collection.

An act authorising a lottery to raise a sum of money for building a wharf at the town of Cambridge, in Dorchester county.

An act to erect a town in Montgomery county, and for other purposes.

An act to prevent insurance by foreigners.

An act authorising the sale of a lot, piece or parcel of ground, lately possessed by Jeffry Dillon Shanley in the city of Baltimore.
