II. AND BE IT ENACTED, That the fines and forfeitures, when collected, shall be applied under the direction of the commanding officer of the respective companies, to and for the use of the respective companies in which the same may be collected.

CHAP. CLVII

C H A P. CLVIII.

An ACT for the benefit of Levin Irving, of Somerset County. Passed December 25, 1830.

WHEREAS it is represented to this general assembly, by the petition of Leah Irving, guardian of Levin Irving, a minor, and only child of William Training of Leah Irving, guardian an of Levin Irving, a minor, and only child of William Irving, late of Somerset county, deceased, that the said Levin Irving is seized in fee-simple of and in one moiety of a saw and gristmill and a small piece of land, lying and being in Dorchester county, in a state of decay, and that it would be greatly to the advantage of the said minor to authorise the selling of the said property; therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That the orphans court of Somerset county shall have full power and authority, upon application of the said Leah Irving, and on the part of the said minor, and being satisfied that it is necessary and will be of advantage to the said minor, to order the sale of a moiety of the said mills and land, lying and being in Dorchester county, the property of the said minor, upon such terms as the said court may think proper, and to appoint a trustee for the purpose of effecting such sale.

III. AND BE IT ENACTED, That any sale made by the authority of the orphans court of Somerset county under this act, shall be notified to, and confirmed by, the orphans court of said county, before the conveyance of the property shall be made, and the trustee, before he enters upon the trust to him committed, shall enter into bond, with good security, to the state of Maryland, to be approved of by the said orphans court, for the due execution of his trust, which bond shall be lodged with the register of wills for the county aforesaid, and the said bond shall be recorded and be subject to be put in suit by any person or persons interested, in the same manner as administration bonds now are.

IV. AND BE IT ENACTED, That the trustee appointed by virtue of this act shall be accountable. to the guardian of the said child, under the direction of the orphans court aforesaid, and pay over the money arising from the sale of said property in such manner as the said court shall or may direct.

V. AND BE IT ENACTED, That any conveyance or deed made by the trustee pursuant to the directions of the orphans court aforesaid, shall and is hereby declared to be valid and effectual to convey all the right, title and interest, of the said Levin Irving, in and to the property aforesaid, to the purchaser or purchasers of the same.

VI. AND BE IT ENACTED, That in case the said Levin Irving should die before he arrives at; full age, the sum of money arising from the sale of the said property shall pass and descend in the same manner, and to the same persons, that the property itself would have descended had it not have been sold by virtue of this act; the interest accruing upon the purchase money to be applied. to the maintenance and benefit of the said minor.

C H A P. CLIX.

An ACT for the relief of Robert Alexander Smith, of Anne-Arun-Passed Decemdel County.

THEREAS it is represented to this general assembly, by the petition of Robert Alexander Smith, that he is sick and infirm, and destitute of any support, and prays the mercy of his county; therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That the justices of the levy court of Anne-Arundel county be and they are hereby authorised and directed to assess and levy, on the assessable property of said county, a sum of money not exceeding thirty dollars, for the support and maintenance of the said Robert Alexander Smith, and that the same be collected as other monies are collected in said county by the collector, and by him paid annually to the said Robert Alexander Smith, or his order.
