And be it enacted, That the county courts of Washington Commissioners county shall appoint five commissioners, who shall estimate the to be appointed amount of damages sustained by any person or persons by rea-for ascertain-son of said road passing through his, her, or their land, or by taking of stone, gravel, or other materials, for the use of the said road, in cases where the parties cannot agree, which estimate shall be final in determining such damages.

CHAPTER 106.

An act to lay out and make public a Road in Caedi County. Passed Jan. 22.

Sec. 1. Be it enacted by the General Assembly of Maryland, Commissioners That James Cameron, Thomas White, and Edward MeVay, be appointed to and they are hereby appointed commissioners to survey and law lay out road and they are hereby appointed commissioners to survey and lay out a road in Cacil county, beginning at the public road near Evan's farm, thence in a straight direction till t intersects the great road leading from Charles-Town to the Rising Sun, at or near a school-house between Robert Cameron's and John Cord's. not exceeding thirty feet in width; Provided, that the said road shall not pass through the buildings, yards, gardens or orchards, of any person, without the consent of the owner or owners

thereof. 2. And be it enacted, That the said commissioners shall cause Plot to be made a plot and certificate of the said road, when so surveyed and and returned. laid out, to be made and returned to the levy court of Cacil county, at their next sitting thereafter, whereupon it shall be their duty to levy upon the assessable property of sail county, a sum of money, such as they shall deem necessary, and to appoint an overseer to open and clear said road agreeably to the plot and certificate aforesaid; and the said road, when opened and cleared as aforesaid, shall be, and the same is hereby declared to be, for ever thereafter, a public road, and shall be kept in repair as other public roads in said county.
