CHAPTER 219.

An act to Suppress Duelling.

Passed Feb. 4.

WHEREAS experience has evinced that the existing remedy for Preamble. tle suppression of the barbarous custom of duelling is inadequate to the purpose, and the progress and consequences of the evil have become so destructive as to require an effort on the part of the legislature to arrest a vice the result of ignorance and barbarism, justified neither by the precepts of morality nor by the dictates of reason; Therefore,

Sec. 1. Be it enacted by the General Assembly of Maryland, Persons fight-That any person who shall hereafter wilfully and maliciously, or ing a duel to be by previous agreement, fight a duel, or single combat, with any mientiary. engine, instrument or weapon, the probable consequence of which might be the death of either party, and in so doing shall kill his antagonist, or any other person or persons, or inflict such wound as that the person injured shall die thereof within twelve months and a day thereafter, such offender, his aiders, abettors and counsellors, being thereof duly convicted, shall be sentenced to undergo a confinement in the penitentiary-house for a period not less than five nor more than eighteen years, any law, custom or usage, of this state, to the contrary notwithstanding.
