a negro man slave named Limerick, and to have and hold the said Dec. Ses. 1817 negro man, in the same right as if he had never been taken out of this state, provided that the said Daniel C. Holliday shall not be authorised to sell the said negro out of the state of Maryland.

CHAPTER 37.

An act, entitled, A supplement to the act for opening and Passed Jan 2. extending North-Street in the City of Baltimore.

Sec. 1. Be it enacted by the General Assembly of Maryland, That North-streetto the city commissioners of Baltimore be and they are hereby em- be extended. powered, to open and extend North-street, on the east side of Jones's Kalls, from the point of its intersection with High-street, fifty feet in width, including the foot pavement, measuring from Humes' warehouse, standing on the south east corner, and running through the same width, until its eastern boundary line intersects Jones's-street, at the south west corner of Gilbert Middleton's dwelling house, and the said street, when so opened and extended, shall be deemed and taken, and is hereby declared to be, a public street and highway for ever thereafter.

2. And be it enacted, That the mayor of the city of Baltimore Freeholders to be and he is hereby empowered to appoint five freeholders, inha- assess dambitants of the city, and not interested in the premises, commis- ages. sioners, who after having given at least ten days notice in one or more of the public papers in Baltimore, and first being duly sworn, proceed to assess and value what damages will be sustained by any person or persons whomsoever, by reason of opening and extending the aforesaid street, agreeably to the several provisions contained in the first section of the law to which this is a supple-

ment.

3. And be it enacted, That all such parts of the original law that Repeal. are inconsistent with the provisions of this supplement, be and the same are hereby repealed.

CHAPTER 38.

Millard, Joseph Harris and James Forrest, or any two of them, on a day by them appointed for that purpose, and notified in the most public places of the county, and elaewhere, as shall seem most expedient to the commissioners aforesaid, at least three weeks previous thereto, who shall meet on the day so appointed for receiving subscriptions, at ten A. M. and continue the same open till five P. M. and if the subscriptions shall exceed the capital, the commissioners shall apportion the same among the subscribers by proportional deductions, so the whole be
