Be it enacted by the General Assembly of Maryland, That whole number inasmuch as the number of directors to be elected by the stockpractical me-holders of the Mechanics Bank of Baltimore, has been diminished chanics itshall by the operation of a clause in the act to which this is a supplement, it shall be deemed a sufficient compliance with the intent and meaning of the charter of the said bank, as now amended, if a majority of the whole number of directors, howsoever elected, or appointed, are practical mechanics or manufacturers, actually carrying on as their principal occupation some mechanical or manufacturing business.

And be it enacted, That the president and directors of the Mechanics Bank of Baltimore, or a majority of them, shall have as other banks the same right and power to grant discounts, in their discretion, unrestricted as to extent of time, amount and security, in the same proportion to the present or any future amount of capital actually paid in, as the president and directors of any other bank within this state, in which the state holds stock, have power to do the same, any thing in the act to which this is a supplement to the contrary notwithstanding.
