CHAPTER 20.

An act to alter and change the Name of Otho Taylor, of

Sec. 1. Be it enacted by the General Assembly of Maryland, That the name of Otho Taylor, of Harford county, be and the same is hereby changed and altered unto the name of Otho Scott; and it shall and may be lawful for the said Otho Taylor, at all times hereafter, to be called and known by, and hold and use the name of Otho Scott, and by this name to sue and be sued in any court of law or equity.

Evans, Joseph Evans, and Samuel Hartly, were appointed commissioners, by an act passed at December session, eighteen hundred and seventeen, to build a bridge over the Patapsco Falls, at Ellicott's old upper mills, on the old road leading from Baltimore to Frederick-town: And whereas, they have by their memorial to this general assembly set forth, that the sum directed to be levied by the said act on the assessable property of Baltimore and Anne-Arundel counties, for the purpose of building said bridge, is not sufficient; therefore,
