WHERHAS Samuel Stone, and others, of Baltimore county, by Premble their petition have represented to this general assembly, that for a a great number of years a private road passed through said Samuel Stone's farm, on which were erected gates; that in the year eighteen hundred and fifteen a law passed declaring the said road a public highway, to be repaired as other public rouds are in said county; Therefore,

1. Be it enacted by the General Assembly of Maryland, That it Authorised to shall and may be lawful for Samuel Stone; of Baltimore county, road o erect and keep two gates on the road leading through his farm, and by his mill, at such place or places as he may think proper. provided the same be on his own land, and provided also, that ho said gates be hung on good and sufficient iron hinges, and kept in repair by the said Samuel Stone, so as to impede as little s possible persons travelling either on horseback, or with cariages of pleasure or burthen.

2. And be it enacted, That if any person or persons after the renalty on perrection of said gates, shall cut, destroy, or remove said gate for them ates, they shall, upon conviction thereof, forfeit and pay to the aid Samuel Stone, for every such offence, the sum of ten dolers, recoverable before a magistrate of said county as other
