Extension not to

CHAP. CXLV. An Act to incorporate the Medical Society of Baltimore.

Hammond, and such persons as they may from time to time elect, and their successors, are hereby declared to be one community, corporation, and body politic for ever, by and under the name and title of The Medical Society of Baltimore, and by and under the same name and title, they shall be able and capable in law to sue and be sued, plead and be impleaded, answer and defend, and be answered and defended, in courts of law and equity, or in any other place whatever, to purchase, take, have and enjoy, to them and their successors, in fee or for a less estate or estates, any lands, tenements, rents, annuities, chattels, bank stock, registered debts. or other public securities within this state, by the gift, bargain, sale, or devise, of any person or persons, bodies politic or corporate, capable to make the same, and the same at their pleasure to alien, sell, transfer or lease, and. apply to purposes as they may judge most conducive to the promoting medical knowledge, and to make, have, and use a common seal, and the same to change and renew at pleasure, and generally to do every other act or thing necessary to carry into effect the provisions of this act, and promote the design of said corporation; Provided nevertheless, that the said medical society of Baltimore, or body politic, shall not at one time hold or possess property
