CHAPTER 45.

An act for the benefit of the Trustees of the Catholic Cathedral Passed Jan. 12, Church, of Baltimore.

SEC. 1. BE IT ENACTED By the General Assembly of Maryland, Trustees may That the trustees of the Catholic Cathedral Church, of Baltimore, borrow. be, and they are hereby authorised and empowered to borrow from any person or persons; bodies politic or corporate; any sum or sums of money, not exceeding in the whole the sum of fifty thousand dollars, at an interest not exceeding six per cent per annum, payable quarterly or half yearly, and to issue certificates therefor under their corporate seal.

2. And BE IT ENACTED, That the said certificates shall be trans- to be transferferable, on the books of the said trustees, according to such rules able as shall be established by the said trustees.

AND BE IT ENACTED, That if at any time after the making Failure to pay and obtaining the said loan, the principal or interest of the same or -remedy. of any part thereof, shall remain unpaid for the space of thirty days next after the time appointed for the payment of the same, that then, and in that case, it shall and may be lawful for the person or persons, bodies politic or corporate, or either or any of them, to whom the same may be due, to make application to a court having equity jurisdiction, for a sale of all or any part of the real estate of
