CHAPTTER 96.

An act for the benefit of Joseph Harris, clerk of Saint Mary's County Court. Be it enacted by the General Assembly of Maryland, That Joseph Harris, clerk of St. Mary's county court, be, and he is hereby authorised and empowered to send out fees in the year eighteen hundred and twenty-four for collection or execution at any time until the first day of April next, any thing in any law to the contrary notwithstanding; -Provided, however, that every sheriff in whose hands fees shall be placed by the said Joseph Harris, for collection, shall be allowed until the first day of June next, to deliver the accounts of fees or bills of particulars to the respective persons, and to the twentieth day of November next, to account for and pay over the money for the said fees.
