Passed Jan. Anact authorising certain powers of attorney therein described to be read in evidence.

Be it enacted by the General Assembly of Maryland, That two powers of attorney each dated on the eleventh day of June, in the year eighteen handred and twenty-three, the one given by Francis Peter Biuer, and the other by James Calixtus Michael de Leritz, to Lavid Williamson, of the city of Baltimore, ratifying and confirming all the acts of the said David Williamson, in the sale of sundry lands named and described in an act of the General Assembly of Maryland, passed at December session, eighteen hundred and twenty. one, entitled, an act relinquishing the right of the state to the lands therein mentioned, and authorising a conveyance of the same, and constituting and appointing the said David Williamson, their attorney, to receive from Stevenson Archer, the purchase money for said lands, the execution of which powers of attorney were on the same day proved by the subscribing witnesses thereto, before M. P. M. Emerigon, president of the civil tribunal of Bordeaux, to be read in evidence in any court of law or equity in this state, without proof of their execution, in the same manner, as they could be read in evidence in virtue of the act of the General Assembly of Maryland, passed at November session, seventeen hundred and eighty-five, entitled, an act directing what shall be good evidence to prove foreign and other debts and deeds and wills, and instruments of writing executed in any of the United States, or in any foreign country, for allowing discounts, and for repealing an act of assembly therein mentioned, if the same had been executed in conformity with the provisions thereof.
