2. And be it enacted, That the said commissioners or a majority of Dec. Ses. 1823 them, shall and they are hereby directed and required, to make or cause to be made a plot of said road, when surveyed as aforesaid, &c. and shall make return of said plot together with a certificate of the courses of said road, to the clerk of Montgomery county, to be recorded among the records of said county, and when the same shall be widened, straightened, amended and made public as directed by this act, the said road shall forever thereafter, be deemed a public highway; and shall be kept in repair as other public roads of Montgomery county; Provided, the said commissioners shall not lay out the said road through the buildings, gardens, orchards or meadows, or through the lands of any person or persons without their consent.

## CHAPTER 185.

An act to repair the High-ways and Bridges in certain parts of the city of Baltimore.

WHEREAS, it has been represented to the General Assembly of Preamble. the state of Maryland, that the High-ways and Bridges in that part of the city of Baltimore lying without the limits of direct taxation, but within the exterior limits of the city, are frequently rendered impassable to the very great injury and inconvenience of the community in consequence of their being no appropriation of money for the purpose

Sec. 1. Be it enacted by the General Assembly of Maryland, That Power to tax. the Mayor and City Council of Baltimore shall have power to lay and collect a direct tax, not exceeding thirty-five cents in the hundred dollars on the assessment of all lands and houses in the said city, lying without the present limits of direct taxation and within the exterior limits of said city, and may enforce the payment of the same in the same manner as is now provided with respect to the direct taxes which the said corporation is now authorised to impose; and the tenants in possession shall be liable to the payment of the said tax imposed upon the premises occupied by them, without its operating however to alter the nature of contracts between landlords and tenants.

2. And be it enacted, That the taxes thus levied, after deducting the expenses of collection, shall be annually applied by the corporation of plied. the city of Baltimore, in making and repairing such of the public highways and bridges within the limits subject to this present assessment, as they shall deem most important to the public necessity and convenience; and the said corporation shall have power to provide by ordinance for the collection and expenditure of said tax, in such manner

as they may deem advisable.

3. And be it enacted, That this law shall continue in force until the Limitation. first day of November, eighteen hundred and twenty-eight, and until the end of the next session of the General Assembly which shall happen thereafter.
