provisions of this section as required of him, he shall be cashiered or Dec.Ses, 1823 fined a sum not exceeding one hundred dollars, in the discretion of

such court martial as the case may require.

12. And be it enacted, That if any enrolling officer as aforesaid, shall omit to enroll any person or persons liable to militia duty within his enrollment. district within the time aforesaid, he or his successor in office shall enroll such person or persons, as well as those who may, from time to time, arrive at the age of eighteen years, whenever the same shall come to the knowledge of said officer, who in making said enrollment shall be attended by one or more of his officers, non-commissioned officers or privates, whom he may select if he should deem it necessary; and the said enrollment shall be entered on the company book of said officer and a return thereof made forthwith to the commanding officer of his regiment; and if any officer, non-commissioned officer or private, shall neglect or refuse to comply with any of the provisions of this section as required of him, he shall be cashiered or fined a sum not exceeding one hundred dollars if a commissioned officer, twentyfive dollars if a non-commissioned officer, and ten dollars if a private,

in the discretion of such court martial as the case may require.

13. And be it enacted, That all the officers, non-commissioned officers, privates and musicians composing the said division, shall assemble regimental & for militia duty on the day as herein after mentioned and as herein company pa directed for the division review; and all the regimental, field, staff and company officers, non-commissioned officers, privates and musicians of each regiment, shall assembly for militia duty on the day as hereinafter mentioned and as herein directed for the regimental parade; and all the company officers, non-commissioned officers, privates and musicians of each company, shall assemble for militia duty on the days as herein after mentioned and as herein directed for the company parades, viz: the companies of the fifth regiment of cavalry on the second Monday in April, second Monday in May, second Monday rade. in June, twelfth day of September, and first Tuesday in October; the companies of the first regiment of riflemen on the second Tuesday of April, second Tuesday in May, second Tuesday in June, twelfth day September, and first Wednesday in October; the companies of the fifth regiment of infantry on the second Wednesday in April, second Wednesday in May, second Wednesday in June, twelfth day of September, and first Thursday in October; the companies of the sixth regiment of infantry on the second Thursday in April, second Thursday in May, second Thursday in June, twelfth day of September, and first Friday in October; the companies of the twenty-seventh regiment of infantry on the second Friday in April, second Friday in May, second Friday in June, twelfth day of September, and first Saturday in October; the companies of the twelfth regiment of cavalry on the second Saturday in April, second Saturday in May, second Saturday in June, twelfth day of September, and second Monday in October; the companies of the second regiment of riflemen on the third Monday in April, third Monday in May, third Monday in June, twelfth day of September, and second Tuesday in October; the companies of the thirty-ninth regiment of infantry on the third Tuesday in April, third Tuesday in May, third Tuesday in June, twelfth day of September, and second Wednesday in October; the companies of the fifty-first regiment of infantry on the third Wednesday in April, third Wednesday in May, third Wednesday in June, twelfth day of September, and second Thursday in October; the companies of the fifty-second regiment of infantry on the third Thurs-
