Ses1 and faithfully do and perform the several duties assigned to me asin the militia of the state of Maryland, and execute the several provisions of this law according to the best of my skill and abilities, so help me God," and a certificate of his having done so, shall be endorsed on the commission by the person who may have administered such oaths, and all officers hereafter commissioned shall take the like oaths, and have the like certificate thereof, endorsed on their commissions, which they shall report in writing, if a major general to the commander in chief, if a brigadier general to the commanding officer of the division, if regimental field officers or brigade staff oflicers, to the commanding officers of their respective brigades, and if company or regimental staff officers, to the commanding officers of their respective regiments, previous to their entering on any of their respective duties; and if any officer shall neglect or refuse to comply with the provisions of this section as required of him, he shall be liable to be cashiered or fined not exceeding one hundred dollars, in the dis- Penalty. cretion of such court martial as the case may require.

55. And be it enacted, That no commissioned officer charged with any violation of this act, for which he might be cashiered, shall offences he suffered to do duty in the division, brigade, regiment or company to which he belongs, nor to resign his commission whilst under such charge, until he has had his trial by a court martial; andevery person so charged shal be tried as soon as a court martial can conveniently be assembled, and shall be furnished by his brigade inspector, adjutant of his regiment or other person as the case may require, with a copy of the charges exhibited against him at least ten days before his trial; and in case any delinquent being duly notified of the time and place of any such court martial, shall refuse or neglect to attend, the said court martial is authorised and empowered to proceed to the trial of such deliquent, in the same manner as if he were personally present; Provided nevertheless, that the said deliquent shall have power of making his excuse in writing or otherwise in cases where he is prevented from attending said court by sickness or absence from said
