

RESOLUTIONS

Passed by the General Assembly of Maryland, at
December Session, 1824.

No. 1.

Passed Dec.
8, 1824.

Payment of
members, &c

Resolved, That the treasurer of the western shore, pay to the several members of the general assembly and the officers thereof, also to the electors of president and vice president of the United States, the amount of the several sums due to them, and for which they obtain certificate from the chairman of the committee of claims.

No. 2.

Passed Dec.
13, 1824.

Lafayette.

Invitation.

Resolved by the General Assembly of Maryland, That in common with their fellow citizens throughout the United States, they entertain the highest respect for the character of *General Lafayette*, whose life has been passed in a continued and arduous struggle for the support of civil liberty, and they are also deeply impressed with a grateful remembrance of his voluntary and valuable services, during the revolutionary war.

Resolved, That in accordance with these feelings, a joint committee of both branches, shall be appointed to convey to *General Lafayette*, an invitation from the legislature to visit the seat of government, at such time as may be most convenient to him, during the present session, and that such committee shall be authorised to make all necessary arrangements for his accommodation, and draw upon the treasurer for such sum as may be required for that purpose.

No. 3.

Charles Jones

Resolved, That further proceedings in Somerset county court, against Charles Jones, late sheriff of said county, on account of defaults entered against him, in two cases against George Dashiell, the former sheriff and his securities, be suspended until the first day of January next.

No. 4.

Stock in the
Bank of Bal-
timore.

Resolved, That the treasurer of the western shore, be, and he is hereby authorised and required, in behalf of the state, forthwith to subscribe, and to make the necessary payment for the whole number of shares remaining in the bank of Baltimore, for which the state is entitled to subscribe, under the charter of said bank.

No. 5.

Passed Dec.
14, 1824.

Payment to
Farmers
Bank.

Resolved, That the treasurer of the western shore, be and he is hereby authorised and directed, forthwith to pay to the farmers bank of Maryland, the sum of eighty thousand dollars, it being a part of the debt due that institution on the loan of eighteen hundred and twenty one; out of any unappropriated money in the treasury; and that the certificate redeemed, be by him immediately cancelled.

No. 6.

Passed Jan.
19, 1825.

Payment to
E. Lynn.

Resolved, That whatever balance may have been remaining due to the late Eleanor Lynn, (who died on the twenty third day of April, eighteen hundred and twenty four,) the widow of Col. John Lynn, on the pension list of this state, be paid by the treasurer of the western shore to David Richardson, who intermarried with Elizabeth, one of the daughters of the deceased, and Jane Lynn, another of her daughters, they being the only heirs and representatives of the said deceased.

No. 7.

Passed Feb.
1, 1825.

Canal bill to
be transmit-
ted.

Resolved, That his excellency the governor, be and he is hereby requested, to transmit forthwith, copies of the act incorporating the Chesapeake and Ohio canal company, passed by the legislature of Maryland at its present session, to the president of the senate and speaker of the house of representatives of the congress of the United States, requesting that it may be submitted to their respective bodies; and copies to the governors of Virginia and Pennsylvania, with a request that they will submit the same to their respective legislatures.
