This house having Considered the Vote of the Lower house touching the Land of the Orphans of Major Billingsley Desired by the Mattapanie Indians Doe Vote that the said Indians shall have the said Land of Billingsley or else be removed to some part of the Land on the other Side of the Creek which they have not sold according to their Desire to the Governor and Council in Case they might not have the Land from Billingsleys Orphan, and do further Vote that the said Indians shall not be seated or Removed to the Land on the Bridge Manner, -

Ordered that the Secretary be desired to Carry this Vote to the Lower house. Viz^t Voted by this house that an Act be Prepared to lay an Imposition upon the several Liquors here under Specified at the rate as followeth viz^t
