**S**ENATE met according to adjournment. Present the same members as on yesterday. The proceedings of yesterday were read. Thomas Contee, Esq; a senator for this state, appeared in the house, and qualified by taking the oaths prescribed by the form of government, and subscribing a declaration of his belief in the christian religion.

The Senate having previously qualified for the purpose, proceeded to the choice of a member in the room of Thomas Johnson, Esq; who declined taking a seat in the senate, and Charles Grahame, Esq; was unanimously elected by ballot.

THIS house having taken into consideration that part of the resolve of congress of the fifteenth of February seventeen hundred and seventy seven, recommending to the legislatures of New-York, New-Jersey, Pennsylvania, Delaware, Maryland, and Virginia, the appointment of commissioners to meet at York-Town in Pennsylvania, on the third Monday of this instant, for the purpose of considering of and forming a system for regulating the price of labour of manufactures, and of internal produce, within these states, and of goods imported from foreign parts, except military stores, are of opinion, that the said recommendation ought to be complied with, and have accordingly resolved to appoint five commissioners, with a power to any three or more of them to act in conjunction with the commissioners of the other states for the above purpose. Should your honours concur with us in opinion, this house will immediately proceed to ballot for the commissioners to be appointed by this state.
