may happen in the board of auditors, which was read, and ordered to lie on the table.

The senate adjourns till to-morrow morning 9 o'clock.

Some money will no doubt be brought into the treasury by loans and by the fale of the ship Desence, and the gallies ordered to be fold. The money now in the treasury, together with what is already in the Joan office, and may be procured by the resolves now passed and sent to your honours for your concurrence, will, we expect, answer the demands that may be made on the treasury, before the next meeting of the general assembly. Impressed with this idea, we wish the journal may pass your house, because we have reason to believe some of the public creditors cannot with convenience remain unpaid; those who can wait, will, we apprehend, be well satisfied with having certificates.
