By the HOUSE of DELEGATES, December 11, 1778.

May it please your honours,

WE are very desirous, for many reasons, to bring this session to a conclusion, and have determined, if possible, to rise on to-morrow. This house propose to adjourn to the first Monday in August next.

The governor communicates to the president a letter from the president of congress, enclosing several acts of congress, which were read, referred to the consideration of the house of delegates, and sent by Brice Thomas Beale Worthington, Esq;

On motion, That the following message:

By the S E N A T E, December 11, 1778.

Gentlemen,

WE are equally desirous with you to bring this session to a conclusion, and shall be willing to adjourn when the necessary public business is dispatched. This house cannot agree to adjourn to the day mentioned in your message by Messrs. H. Goldsborough and Carmichael, because we are satisfied that the public safety will require an increase of the rate imposed by the act to raise the supplies for the year seventeen hundred and seventy-nine, before that time. We therefore propose to adjourn to the 26th of April next. If the rate aforesaid can be increased this session by a supplementary law, this objection to our adjournment to a long day will be removed, and we will then agree to the day proposed by you.
