WHEREAS the appropriation of vacant lands by the several states, during the continuance of the war, will, in the opinion of congress, be attended with great mischiefs, therefore RE-SOLVED, That it be earnestly recommended to the state of Virginia, to reconsider their late act of affembly for opening their land-office; and that it be recommended to the faid state, and all other states similarly circumstanced, to forbear settling or issuing warrants for such unappropriated lands, or granting the same during the continuance of the present war.
