amendments, and sent to the house of delegates by Upton Sheredine, Esq;

Amendments proposed. Between the 5th and 6th line from the bottom of the 2d page insert the following clause: " And be it enacted, That the said commissioners, before they enter upon the trust reposed in them by this act, shall take the following oath, to wit: " I, A. B. do swear, 66 that I will diligently and faithfully, without fear, favour, affection, or partiality, execute the duties and trust reposed in me by the act, entitled, An act for the immediate supply of flour and other provisions for the army." Which oath any justice of the peace may and is hereby required to administer."

After the word "Susquehanna," in the 10th line of the 4th page, infers the words "by the western shore conveyance." After the word " require," in the 11th line of the same page, infert " by the eastern shore conveyance." After the word " supplies," in the 10th line from the bottom of the 4th page, insert the following clause: " And be it enacted, That in case of any loss to the owner or owners of any waggon, team, or driver, employed in virtue of this act, that the same shall be ascertained by the oath of the owner or owners, and the value, by an appraisement or valuation by indifferent persons, to be paid by either of the treasurers, as other public claims, and charged to the account of the United States, such loss and valuation being first certified to either of the faid treasurers by any one of the commissioners aforesaid."
