I D A Y, April 14, 1780.

HE senate met. Present the same members as on yesterday. The proceedings of yester-

day were read. The order of the day, for taking into consideration the bill, entitled, An act for the seizure and confication of British property, was read. The president suggested to the senate, that as the estate of the late proprietary would be involved in a determination upon the said bill, and as he had formerly been agent for the faid proprietary, and the censorious might suppose him under prejudices from that circumstance, to avoid any imputation or censure, he begged the senate to excuse him from voting on the said bill, but informed the senate, he would on this, as on all other occasions, vote his sentiments, if required by them to vote. The senate determined not to excuse the president from voting on the said bill.

Mr. Goldsborough also informed the senate, that he had at this time some considerable property in England, and observed, that as he might probably be materially affected, in point of interest, by the determination of this house upon the bill now about to be taken under consideration, he conceived there was an impropriety, and felt a great delicacy with himfelf, in giving a vote upon a question, in which he might be so much concerned; that he had formed an opinion upon the subject, which he was satisfied was founded upon principles of law, equity, and justice; but though he knew that his interest had not influenced him in forming that opinion, nor should it,
