TO the honourable the General Assembly of Maryland, the petition of Elizabeth Caile, of Cambridge in Dorchester county, widow, humbly sheweth unto your honours, That at the commencement of the present war, her and her infant son's estate consisted almost wholly of sterling and current money lent out at interest, which interest was at that time abundantly sufficient to support both your petitioner and her sons in ease and comfort, and those who had borrowed your petitioner's bills and money, having borrowed the fum many years before the depreciation of the currency, have several of them accumulated handsome and independent fortunes thereby, whilst your petitioner, by being paid off fince the currency hath not represented one shilling in the pound, is reduced from ease and independence to indigence.
