Messieurs Maccubbin and Dennis, from the house of delegates, deliver to the president the following resolutions:

BY THE HOUSE OF DELEGATES, NOVEMBER 17, 1780.

RESOLVED, That the general assembly highly approve the conduct and public spirit manifested by the merchants and inhabitants of Baltimore-town, and their fitting out the brig and schooner in the manner and on the terms by them proposed.

RESOLVED, That the state ensure to Mr. John Gwinn three hundred thousand pounds continental currency, the estimated value of his brig, with rigging and sails and twelve six pounds, if taken or lost while employed in the proposed expedition against the enemy's cruisers, and that the state repair or make good any damage the said brig may sustain in the public service.

RESOLVED, That the state ensure to Mr. Thomas Worthington two thousand five hundred pounds specie, the estimated value of his schooner, with rigging, sails, and twelve four pounds, if taken or lost while employed in the proposed expedition against the enemy's cruisers, and that the state repair or make good any damage the said schooner may sustain in the public service.

RESOLVED, That the state reimburse the money expended in fitting out the said brig and schooner, and that during the cruise the said vessels be subject to the order and directions of the governor and council.
