On reading the memorial of Mr. Legh Master, RESOLVED, That the same be referred to the governor and the council, with power to give such orders respecting the seizure of the slag as they may think proper; and that if they find that no intended and gross violation of the slag has happened, that they give orders for the discharge of the vessel of the said Legh Master, and for his departure with his vessel, in such time and with such provisions as they may think necessary for the use of the crew and prisoners carried by him.
