No. 10. An act to enable the sheriffs of this state to take bail bonds in certain cases.

No. 11. An act to extend the time and to enforce the collection of the taxes in several of the counties within this state, and for other purposes.

No. 12. An act to continue the acts of assembly therein mentioned.

No. 13. An act for the relief of John Needles, of Talbot county, and Richard Clarke, of Saint Mary's county, collectors of the tax.

No. 14. An act to prohibit the exportation of Indian corn, wheat, wheat flour, and flesh provisions, by land, for a limited time.
