BY THE HOUSE OF DELEGATES, JANUARY 3, 1781.

RESOLVED, That his Excellency the governor of this state be allowed, for the current year, fifteen hundred pounds; the council, each, four hundred pounds; the chancellor six hundred pounds; the judges of the general court, each, five hundred pounds; the judges of the court of appeals, each, two hundred pounds; the judge of the court of admiralty two hundred pounds; the treasurer of the western shore five hundred pounds; the treasurer's deputy two hundred and fifty pounds; the treasurer's clerk two hundred and fifty pounds; the treasurer of the eastern shore three hundred pounds; the auditor-general four hundred and fifty pounds; the auditor's clerk two hundred and fifty pounds; the clerk to the governor and council three hundred pounds; the assistant-clerk to the governor and council two hundred pounds; the messenger to the governor and council one hundred and twenty-five pounds; the commissary of stores two hundred and fifty pounds; the register of the land-office seventy-five pounds; the clerks of the two houses, each, one hundred pounds; the clerk of the court of appeals thirty pounds; the delegates to congress, each, four pounds per day for every day they shall attend congress, or be on their journey to or from congress; and that the said salaries shall be paid in Spanish milled dollars at seven shillings and six-pence each, or in gold or other silver in proportion, or in bills of credit at the passing value.
