

Messieurs Brogden and Stainton, from the house of delegates, deliver to the president the following resolution :

BY THE HOUSE OF DELEGATES, MAY 30, 1781.

RESOLVED, That the delegates from this state in congress be instructed to apply for at least five hundred stand of arms and accoutrements, with which to arm the continental troops lately raised in this state; and that they strongly urge congress to a speedy compliance with this request, as this state cannot be expected, in its present circumstances, to part from any of the fire-arms it has. And also to represent to congress the real difficulties this state is under to provide cloathing for her men, and to request congress to assist this state with cloathing if they have it in their power.

B. Worthington, Esq;

Messieurs Winder and Norris, from the house of delegates, deliver to the president a bill, entitled, An act to repeal the several acts of assembly heretofore made relative to the export of provisions, endorsed; "By the house of delegates, May 29, 1781: Read the first time and ordered to lie on the table.

Messieurs Bayly and Ward, from the house of delegates, deliver to the president the engrossed bills No. 1 and 2, with the paper bills thereof, which engrossed bills were thus endorsed; "By the house of delegates, May 30, 1781: Read and assented to.

The house of delegates appeared, and the following engrossed bills were signed, and the great seal affixed thereto, in presence of both houses.

No. 1. An act for the adjournment and continuance of the general court of the western and eastern shore, and the several county courts therein mentioned, and for the other purposes therein mentioned.

No. 2. An act to repeal the several acts of assembly heretofore made relative to the export of provisions.

The senate adjourns till to-morrow morning 9 o'clock.
