BY THE HOUSE OF DELEGATES, JUNE 9, 1781.

RESOLVED, That this general assembly approve the commission granted by his Excellency the Governor in council, dated the 28th day of March last, to Matthew Ridley, Esq;

RESOLVED, That this state will make good, and punctually execute, any contract which may be made by the said Matthew Ridley, for the yearly payment of one thousand hogheads of tobacco, or four thousand barrels of flour, or both or any part of either of them, to be delivered in this state, at a stipulated price, or the current market price at the time and place of delivery, to discharge the interest which may be agreed on for any loan or credit he may obtain in Europe on behalf of this state, till payment of the principal; or if he should contract as aforesaid to the amount of one thousand hogheads of tobacco, or eight thousand barrels of flour, or both, for payment of a principal sum, this general assembly will fully execute such contract.
