BY THE HOUSE OF DELEGATES, DECEMBER 7, 1782.

RESOLVED, That the lots, dwelling houses, and buildings, in the city of Annapolis, formerly belonging to Sir Robert Eden, and the house and kitchen furniture, houshold goods, and other property, used and lest by him, be put in the possession of his Excellency the governor, to be by him used and enjoyed, until the general assembly shall otherwise direct.

That the governor and the council be requested to direct, from time to time, any repairs to be made to the said dwelling house and other buildings, and the paling of the said lots, as may be

necessary to preserve them fit and proper for the residence of the governor.

That the intendant of the revenue be directed to provide and pay into the treatury as much money as the governor and the council may determine to be necessary to make the repairs to the faid house and buildings, not exceeding for the present repairs the sum of five hundred pounds carrent money.
