BY THE HOUSE OF DELEGATES, JANUARY 6, 1783.

RESOLVED, That the loan made to Matthew Ridley, Esq; by Messieurs Van Staphorst, of Amsterdam, be, and hereby is, ratified and confirmed.

Whereas it appears by the proposals communicated the 26th of July past by Matthew Ridley. Esq; to Messieurs Nicholas and Jacob Van Staphorst, to be by them approved, that the said Messieurs Nicholas and Jacob Van Staphorst were to engage, on account of this state, to the faid Matthew Ridley, or order, the sum of 300,000 florins, and to extend the loan to 600,000, and even to a much larger sum; and whereas only part of the 300,000 florins may as yet be advanced;

RESOLVED, That the said Matthew Ridley be directed, on receipt of these resolves, or instructions from the governor and council given in pursuance thereof, to suspend contracting for any further loans of money on behalf of this state, until the further order of the general assembly, and not to purchase, after receiving these resolves or the instructions aforesaid, any military stores, cloathing, or other effects, with the money borrowed.

RESOLVED, That Matthew Ridley, Esq; be directed to govern himself in the shipping the arms, blankets and cloathing, according to circumstances, and the probable continuance of the war, and according to such instructions as he shall from time to time receive from the governor and the council, and if good reason to believe peace will take place, to return the money in
