Charles Carroll, of Carrollton, Esqui brings in and delivers to the president a bill, entitled, An act to repeal part of an act to continue civil causes depending in the general court for the western shore, and for other purposes, passed at a session of assembly, begun and held at the city of Annapolis in the year of our Lord one thousand seven hundred and eighty-three; which was read the first time and ordered to lie on the table.

Whereas this general affembly have a high sense of the honour conferred on this state, by the resolution of Congress making Annapolis their temporary place of residence: And whereas, by their resolution of the 21st of October, it is the intention of Congress to erect a sederal town at or near George-town, on the Patowmack: Therefore, Resolved unanimously, That whenever the United States in Congress affembled shall determine on a place within this state for a sederal town, the extent of ground and the nature and boundaries of its jurisdiction, that the general assembly will take measure to make their residence in this state as agreeable as in their power.
