edne page, after the word "town," third line from the bottom, infert, "Provided always, and be it enacted. That if any person shall apprehend himself aggrieved by the determination of the faid commissioners in the premises, such person may, within three months next after such determination, appeal from the same to the general court of the western shore, which court shall have full power and authority to hear and determine such appeal, and to make all orders necesfary for obtaining full information upon the subject of dispute, and shall hear such appeal at the first court if it can be done with justice to the parties, and the judgment and determination of the said court shall be final, and being certified to the commissioners aforesaid, they shall act in conformity thereto in completing their survey and location aforesaid." Page fourth, after the word, " therein," thirteenth line, insert, " faving to all persons whatsoever their right of property in any of the faid ground fo made and extended as aforefaid, and in the lots or land from which such ground may be made and extended, and the right to make and extend ground as aforesaid, and the right to the water or land covered by water, which rights are not meant or intended in any manner to be interfered with, tletermined on, or affected by, this act." Fifth page, after the word "pass," third line from the bottom, insert, "Provided that the proprietors of the ground through which the faid canal shall pass, and those interested in the faid canal, shall make and constantly keep in repair a good and sufficient bridge over the said canal, at such place as is most convenient and proper for a road or way from the lower ferry of Patapsco river to Baltimore-town, to be determined by the commissioners of the said town, or a major part of them, for travellers and others securely and conveniently to pass; and if the said proprietors, and those who shall be interested and engaged in the cutting of the said canal, shall neglect to make such bri ge, or to keep it in proper repair after made, then the justices of Baitimore county are hereby authorised and empowered to assess and levy such sum or sums of money upon the faid proprietors of land, and others interested in the said canal, as will be sufficient for the purposes aforesaid; and every proprietor and person interested in the cutting the said canal shall before the same is begun, enter his or her name as a proprietor or person interested, in a list of fuch perfons to be kept by the commissioners of Baltimore-town, which list, when completed, shall be by the said commissioners returned to the clerk of Baltimore county court, by him to be recorded.

Samuel Hughes, Esq; brings in and delivers to the president a bill, entitled, An act for straightening and repairing the road from Baltimore-town to the lower ferry on the river Sufquehanna; which was read the first time and ordered to lie on the table.

The bill, entitled, An act for the relief of Rovert Long, of Baltimore county, was read the

fecond time with the proposed amendments and will pass.

Amendments proposed. Strike out from the word "Long" in the ninth line of the second page, to the word " or" inclusive in the eleventh line. After the word " ascertain" in the twelfth line of the same page insert " on oath." After the word " to" in the second line from the bottom of fame page, strike out "either of the modes" and insert "the mode." Strike out from the word "when" in the south line and third page to the word "or" inclusive in the fifth line. After the word "arbitrators" in the fixth line infert "on oath."

The bill, emitled, An act for the benefit of Eleanor and Charlotte Frazier, was read the fecond time with the proposed amendment, passed, and with the above bill was sent to the house of delegates by Thomas Stone, Eiq;

Amendment proposed. Strike out the word "subjects" in the second line from the bottom in the first page and intert "citizens."

Mr. Bowie, from the house of delegates, delivers to the president the following resolutions:

THE HOUSE OF DELEGATES, JANUARY 6, 1785.

Whereas the bills of credit emitted in virtue of the law of May seventeen hundred and eightyone, were finally to be funk and deftroyed between the twenty-fifth day of December seventeen hundred and eighty-four and the twenty-fifth day of June seventeen hundred and eighty-five, and there remains now in circulation about eight thousand seven hundred and twenty-fix pounds. nineteen shillings and nine-pence of the faid emission, RESOLVED, That the holders or possessions of any of the faid bills of credit, may deliver them to the treasury of the western shore at any time before the twenty-fifth day of June next, and receive gold or filver to the amount, and the treasurer of the western shore shall lay apart a sufficient sum of the money now in the treasury for that purpose, and after the said twenty fifth day of June next the said bills of credit shall not be redeemed; and any bill brought in shall be counted and destroyed by a committee of both houses, to be appointed at the next session of assembly which shall happen after the said twentyfifth day of June next.
