BY THE HOUSE OF DELEGATES, JANUARY 9, 1786.

WHEREAS it is represented, by the memorial of colonel Alexander Lawson Smith, that he was entitled to the rank of lieutenant-colonel in the late federal army, and refigned the faid commission in the year seventeen hundred and eighty, and accepted of a commission of lieutenantcolonel commandant in the regiment extraordinary, raided by the state of Maryland in the afore faid year, with which he joined the fouthern army, and continued in the service until he was requalled by an act of assembly of this state, passed at October session in the same year; and where as, by the said act, it was among other things enacted, That the field and commissioned officers of faid regiment should be recalled, and that they be reimbursed the extraordinary expence by them incurred, and over and above the pay due to them at the time of their discharge, should receive one year's pay, deducting therefrom the money and value of the cloathing and other necellaries by them received, with a proviso that colonel Alexander Lawson Smith should hold the rank of lieutenant-colonel, as a supernumerary officer of this state, in the continental service, he having religned his commission in the continental service for the purpose of accepting the comm and of the faid regiment extraordinary, and being entitled to the rank of lieutenant-colonel in the continental army; and the governor and council were requested to write to the board of war, desiring them to make out a commission accordingly. And whereas, the public faith is plighted to the said Alexander Lawson. Smith, by the said act, to secure to him the advantage incident to a lieutenant-colonel's commission in the continental service; therefore Resolved, That the auditor general be authorised and directed to liquidate and adjust the claim of the said Alexander Lawson Smith, to commutation as lieutenant-colonel in the continental service; and in the adjustment of the said claim, the auditor is hereby directed to deduct out of the five years commutation, the one year's pay advanced to the said Alexander Lawson Smith, over and above the pay for the time of his service in the regiment extraordinary, to the time of his discharge; and that the auditor be empowered to draw on the treasury for such sums of money as may be necessary to purchase final settlement certificates, to the amount of the balance due on the adjustment of the aforesaid claim, and deliver the same to colonel Smith, in sull of his demands on this state as liqutenant-colonel; and that the same be charged to the United States.
