GENTLEMEN

THE amendments made to the bill to prevent the exportation of unmerchantable tobacco, by the conferrees of both houses, have been reported and agreed to by this house. The amendments being difficult to be understood and read without inserting them in the bill, we have thought proper to have the bill with the amendments fairly transcribed, inserting in the fair copy such of the sheets of the original bill as have sew or no interlineations. As the original bill has undergone very considerable and important alterations, and the bill transcribed with the amendments aforesaid differs materially from the bill as sent to us; we return your bill with our negative, not doubting but that the corrected bill which we have passed and now send will meet the approbation of your house.

The president lays before the senate, a petition from Mountjoy Bailey, administrator of Christopher Edelen, late of Frederick county, deceased, on behalf of himself and several persons who were securities for the said Edelen's collection of the public taxes when sheriff of the said county, praying to be empowered to collect the arrearages of taxes due to the said Christopher Edelen, in the same manner as the said Edelen in his life-time was entitled to collect them; and a petition of Henry Symmonds, respecting depreciation of pay; which were read and ordered to lie on the table.

The fenate adjourns till to morrow morning 10 o'clock.
