Amendment proposed. In the 2d page and 3d line from the bottom, after " years," insert " provided, that nothing in this act shall be taken to extend the payment of the half pay aforefaid to the widows and children of fuch officers who have died in the service of the United States, and have already, under particular laws, received provisions adequate to the faid half pay; and if the said particular provisions are not adequate to the said halt pay, then such deficiency shall be

paid as aforefaid, to the widows and children as aforefaid."

MAY IT PLEASE YOUR HONOURS,

THIS house have agreed to the report from the conference, except that the assessment of fifteen shillings in the bill to raise the supplies for the next year be reduced to the sum of ten shillings, and have determined that the sum be reduced to seven shillings and six-pence, and we request that the bill may be returned to us for amendment accordingly.
