Whereas it is represented to this general assembly by the petition of Thomas Cansield, that he entered into the service of the United States by enlisting as a private soldier in the sourch Maryland regiment, then commanded by colonel Steward, in the year 1781, and continued to serve in the Maryland line for more than two years, and until the end of the war; that he was employed as a labourer to the workmen on the stadt-house; that early in the morning of the 12th November 12st, he ascended the scassfold of the stadt-house to the roof thereof with a load of shingles, when his foot unfortunately slipped, from the fright of which, and not having it in his power to lay hold of any thing for his safety, he fell from the roof of the stadt-house to the ground, at least eighty sect, whereby he was so much brussed, and received so many contusions, that he was carried home sense less, where he continued several weeks not expected to live; that he is in a languishing condition, and totally deprived of earning any kind of support for himself, his wise and two helpless children, who were dependent on him for their bread from his daily labour; Resolved, That the justices of Anne-Arundel county orphans court are hereby authorised and empowered to make the same allowance to Thomas Cansield as maimed and disabled soldiers are allowed, while he continues unable to support himself by labour.

Whereas it appears, by the petition of Vachel Downes, of Queen-Anne's county, one of the executors of Samuel Ridgaway, late of said county, deceased, and late collector thereof, appointed by law to collect the arrears of taxes due to the said deceased, that he hath found amongst the papers of the deceased divers certificates, a list whereof is annexed to his said petition, and that he believes the said deceased intended to have paid into the treasury such of the said certificates on interest, as were payable by law for public taxes, but was prevented by death; that the petitioner hath, fince the said collection has been put into his hands, offered the said certificates to the treasurer of the eastern shore, towards discharging the said arrears, who resused to receive the same without an oath, such as the petitioner could not take, unless by order of the legislature: And whereas this general assembly are of opinion that relief ought to be given in the premises; therefore Re-ED, That the faid Vachel Downes be allowed to pay into the treasury any such certificates as by law are receivable for public taxes, in discharge of the arrears due from the said deceased, without taking the oath in such cases required by law, provided he makes it appear, to the satisfaction of the treasurer, that he the said Vachel Downes came into possession of the said certificates, fo by him offered in payment, in such manner as by his said petition is set forth.
