THE joint committee appointed to inquire into the issuing, during the course of last winter and spring, from the continental loan-office in this state, of some part of the four tenths of the continental state money reserved to congress, and to devise such means as might by them be deemed most effecsual to prevent the state sustaining any injury and loss by the issuing of such money as aforesaid, beg leave to report, that they find on inquiry, that there has been issued from the continental loan-office, in virtue of orders drawn by the commissioners of the board of treasury in the months of December and March last, the sum of 54,642 and \$7 ths continental state dollars; whereupon your committee came to the following resolutions, which are submitted to the consideration of both houses.
