By THE SENATE, DECEMBER 21, 1788.

GENTLEMEN,

WE have passed the bill to make valid the proceedings of Augustine parish, in Cecil county, although we are apprehensive the passage of such bills may occasion uneasiness, and excite jealousy, until some general regulation shall be adopted by the legislature on the principle of the bill originated in this house for that purpose, and rejected by yours for want of time to consider the different provisions of the said bill, as suggested in your message. The principle of the bill, we are firmly persuaded, cannot be questioned, although from the tenor of the expressions in your message, an opinion may be taken up by our constituents, that your house is not entirely satisfied that the general object of the incorporating bill is not liable to exception. By the declaration of rights, all persons professing the christian religion are entitled to equal privileges; and by the act for the establishment of select vestries, and the act to provide a fund for the relief of the widows and children of the clergy of the protestant episcopal church in this state, certain privileges are confirmed, and extended to the protestant episcopal church, and until similar rights and privileges are conferred on all the christian churches, societies and congregations, they cannot, with propriety, be said to enjoy equal rights and privileges.
