The bill, entitled, An act to enable James Gittings, John Gorsuch and John Merryman, the purchasers of confiscated lands, to obtain patents for the same, and other purposes therein mentioned, was read the second time by especial order, passed; and with the above resolution and bill, and the bill, entitled, A supplement to an act for the more effectual punishment of criminals, sent to the house of delegates by John Henry, Esquire.
