Amendments proposed. After the words "original act," in the 5th line, insert "lying formerly within the temporary line of Pennsylvania, and now included within the limits of the state of Maryland." After the word "lands," in the 9th line, strike out the words "till the 10th day of May next," and infert " and included in the former act, until the twentieth day of March next, and against such persons as purchasers of such property so circumstanced, and intended to be relieved by this act, until the tenth day of June next." At the end of the bill add "and the same additional time is hereby given to any person or persons interested in the lands comprehended in this act to exhibit his or their petition to the chancellor, to obtain an investigation of their respective rights or titles, in the manner provided in the faid original act, and according to the true intention
